A. Membership

a. Structure of Steering Committee (SC)

The structure of the current SC is indicated in Table 1. There have been no changes to its composition in the reporting period.

However, levels of active participation in commission matters for a range of SC-members declined or continued to be very low. In some instances, not a single activity or attendance of meetings was recorded over the past 4 years, especially of some newly appointed members. Assigned task as listed in Tab. 1 were not fulfilled leaving most of the administrative work to the chair and to his deputies. This is a concerning trend that needs to be addressed. On the other hand, tangible ongoing support was provided by prof. Tony Jones as retired chair and honorary member of the SC.

b. Member statistics

Based on a decision taken in 2016 that was aimed to curb the uncontrolled grow of mostly inactive members through simply adding email address of one-time attendants to a circulation list, we only accept applicants as new members who submit filled-in member templates outlining their areas of interests/ expertise and research profile in the field of water. This information is displayed on our website to facilitate better collaboration within and outside the Commission (Members – IGU Commission for Water Sustainability (igu-water.org).

Currently, the Commission has a total of 64 registered members of which about a third (33%) is female. Some 85% of members are academics, 44% are professors while 15% are practitioners. Members originate from 26 countries on six continents of which 10 are in Europe, 7 in Austral-Asia, 5 in Africa and 4 in the Americas. Of these countries, 11 are falling in the high-income category representing 37% of members, 9 are middle-income countries representing the majority of members (48%) and 6 are low income nations accounting for 15% of members.

B. Meetings

a. Meetings held

While no dedicated Commission meeting was held during the reporting period, the following two meetings were organised by members of our Commission of which associated calls for papers were distributed among our membership.

 Prof. Winde represented the Commission on behalf of the International Science Council (ISC) at the *UN Water Conference* held on 21-24 March 2023 at the UN headquarters in New York (USA) presenting at the General Assembly the ISC Water Policy Brief he compiled together with an international ISC expert group on water (https://council.science/publications/water-

policy-brief/).

- Prof. Zaharia organised the *36th Conference of the International Association of Climatology* (AIC) taking place from 3 to 7 July 2023 in *Bucharest, Romania*. The overarching theme was "Climate, water and society: changes and challenges".
- Prof. Suresh organised the 7th International Conference of National Association of Geographers in India on "Clean Water, Good Health, Sustainable Cities and Communities" held at Department of Geography, School of Liberal and Creative Arts, Lovely Professional University, Phagwara, Punjab, India from 18th to 19th October 2023. More than 200 participants from different parts of India and worldwide attended the conference on both days.

c. Meetings planned

The Commission envisages to actively participate in the upcoming 35th IGC from 25-30 August 2024 in Dublin, Ireland. In August 2023 the following proposals have been submitted to the LOC via the provided online platform and distributed to all members:

• 'Clean water and sanitation for all' – opportunities and challenges to still achieve SDG

6 by 2030

Status: approved under the conditions that a minimum of four corresponding papers are submitted and accepted.

• Urban water crises – the new normal?

Status: approved under the conditions that a minimum of four corresponding papers are submitted and accepted.

• Emerging water issues – anticipating research and new solutions

Status: approved under the conditions that a minimum of four corresponding papers are submitted and accepted.

• Advances in hydrological methodology and water management

Status: approved under the conditions that a minimum of four corresponding papers are submitted and accepted.

• Problems in the face of plenty: water issues on the Emerald Isle; Open session

Status: <u>not approved</u>; The two generic reason provided by the LOC for rejecting session proposals were both not applicable to session 5 leaving it unclear why the proposal has been rejected.

In addition to the sessions above, Prof. H. Beckedahl, in consultations with the chair, submitted a special proposal on wetlands:

• Wetlands: Changing landforms under changing environmental and climatic conditions

Status: approved under the conditions that a minimum of four corresponding papers are submitted and accepted.

Furthermore, the LOC decided to allocate the following three sessions to our Commission unilaterally submitted by non-Commission members, explaining a certain degree of overlap with the sessions listed above:

• Geographies of rivers and floodplains

Chairs: Emily Rick1,2, Dr. Jonathan Turner1, Kate De Smeth1; 1University College Dublin, School of Geography, Dublin, Ireland. 2Teagasc Research Centre, Wexford, Ireland

Status: approved under the conditions that a minimum of four corresponding papers are submitted and accepted.

• PFAS in the freshwater environment: occurrence, pathways and monitoring

Chairs: Dr Susan Hegarty1, Prof Fiona Regan1, Prof Jennifer Tank2; 1DCU, Dublin, Ireland. 2University of Notre Dame, South Bend, USA)

Status: approved under the conditions that a minimum of four corresponding papers are submitted and accepted.

• Water resources management and planning

Chairs: Dr. Seema Rani; Dept of Geography, Institute of Science, Banaras Hindu University, Varanasi, India)

Status: approved under the conditions that a minimum of four corresponding papers are submitted and accepted.

In total, eight sessions were tentatively approved/allocated for/to our Commission.

The corresponding call for abstracts opened on 3rd October 2023 and closes on 12 January 2024. A reminder to submit abstracts to the approved sessions has been sent out by the chair to all members on 25 October 2023.

a. Collaboration with other IGU Commissions and Task Forces

IGU book project (Bansky & Meadows [eds.])

Based on input of various Commission members a draft manuscript was compiled in accordance with the templates sent out by prof. Bansky. Unfortunately, there was little follow-up from the side

of the editor resulting in our Commission eventually being left out of the volume, despite repeated efforts from the chair ensure inclusion. An alternative way of publishing the compiled material could perhaps be explored.

b. Collaboration with other international, intergovernmental or multidisciplinary bodies

Cooperation with UN-agencies continued by some members of the Commission including the Intrenational Atomic energy Agency (IAEA) (Coordinating Group for Uranium Legacy Sites on Africa – meeting in South Africa; CGULS Central Asia – meeting in Tadshikistan, whose Government was the co-host of the UN-Water Conference in New York in March 2023 together with The Netherlands. Projects with the International Agency for Research on Cancer (IARC) of the WHO (Health effects of environmental uranium exposure) and work within a 6-country-consortium implementing an approved proposal for establishing a joint MSC-course within the EU Erasmus Mundo Programme (Belgium, Brazil, Germany, Norway, Portugal, USA) continued.

c. Cooperative efforts with the International Science Council (ISC)

UN-Water Conference 2023: ISC representation

After attending the preparatory meeting in New York in late 2022, prof. Winde proposed to ISC to appoint a group of water expert from member institutions of the ISC for jointly preparing a consolidated ISC input at the upcoming conference. In early 2023, a 35-member strong group of international water experts was assembled and discussed major aspect to be presented at the UN Water conference. Subsequently, the Water Policy Brief of the ISC was developed with prof. Winde acting as coordinating lead author. Selected key points of the ISC Water Policy Brief were presented by F.
